“THE SING-OFF”
APPLICANT AGREEMENT AND GENERAL RELEASE

1. I hereby acknowledge that I have voluntarily agreed to participate in open auditions for the new television series currently entitled “*THE SING-OFF*” (the “Program”) produced by Avoca Productions, Inc. (“Producer”) and intended for initial exhibition on one or more of the distribution outlets of NBC Universal Media, LLC or any of its parent, subsidiary or affiliated entities (collectively, “NBCU”). I have read, understood and voluntarily agree to abide by the terms of this Applicant Agreement and General Release (“Agreement and Release”). As an inducement for Producer to consider me as a participant for the Program and for other good and valuable consideration which I have received, I am making the representations, disclosures and agreements set forth herein. I understand that I may be disqualified as an applicant and/or a contestant if any of the representations or disclosures made by me in this Agreement and Release are false, or if I otherwise fail to abide by this Agreement and Release. If I am selected by Producer as a semi-finalist, I understand that I will be asked to provide further personal information to Producer and to submit to a background check. I understand that I have the right to refuse to submit to such background check, but that if I do refuse, I will no longer be considered for participation in the Program.

2. I am at least 12 years of age. If I am under the age of 18, my parent(s) and/or legal guardian(s) have signed the acknowledgment and consent form attached.

3. I am a legal United States resident.

4. I am not a candidate for public office and if I am selected to be a participant on the Program, I agree not to become a candidate for public office until one (1) year after the initial telecast of the episodes of the Program in which I appear, if at all.

5. Producer and NBCU reserve the right to declare ineligible any person whom either of them determines, in its sole discretion, is sufficiently connected with the production, administration, judging or distribution of the Program, such that his or her participation could create the appearance of impropriety. Producer and NBCU may also consider whether I or any member of my immediate family or anyone living in my household is or has been within the last two (2) years an employee, officer, director or agent of any of the following:

(i) Producer, Sony Pictures Entertainment Inc., Sony Pictures Television Inc., or any other person or entity involved in the development, production, distribution or other exploitation of the Program or any variation thereof;

(ii) NBCU or any station or network owned and operated by NBCU;

(iii) Any sponsor of the Program or its advertising agency; or

- (iv) Any person or entity supplying goods, services or prizes (as applicable) to the Program, including, without limitation, Epic Records or Sony Music Entertainment.

6. I understand and acknowledge that the principal nature and purpose of the Program is to produce a television program in which a competition will be conducted to select an excellent a cappella singing group. The Program is a reality/competition show in which a cappella singing groups will compete in successive episodes, until only the top group remains. The winning group will enter into an exclusive recording contract with Epic Records/Sony Music Entertainment.

7. I irrevocably grant to Producer, NBCU and all other Released Parties (as defined in Paragraph 15 below) the right to film, tape, record and photograph my auditions, interviews, original songs, statements, singing and appearance (including my name, voice [singing and speaking], and likeness) (collectively the "Material"); to use any and all information, including biographical information and/or any materials I have supplied (including, without limitation photographs or videotapes of myself, songs written by me, by the Released Parties or otherwise, any and all interviews, auditions, backstage appearances, etc. conducted by the Released Parties, as well as other information and material they may have received from other sources) in connection with the Program (all of the foregoing shall also be included within the definition of "Material"); and to edit, distribute, exhibit and exploit the Program and the Material, in any manner at the Released Parties' sole discretion, in all media, by any method now known or later discovered, throughout the universe in perpetuity, including, without limitation, advertising, marketing, promotion and merchandising of the Program, the Released Parties' business activities and the business activities of the networks, stations, sponsors and other users and exhibitors of the Program. Producer shall own all right, title and interest in and to any and all recordings made by Producer, including all rights of production, manufacture and exhibition thereto, including the copyright therein; provided, however, that I shall retain ownership of any of my original songs which I perform. I further agree that the Released Parties may use my likeness and the Material in connection with any promotion, publicity, marketing or advertising. I grant the rights hereunder whether or not I am selected to participate in the Program in any manner whatsoever. I understand that I will not be paid any money for granting Released Parties these rights or for signing this Agreement and Release.

8. If I am selected by Producer to be a participant on the Program, I understand that I must be available to participate in the production of the Program in the Los Angeles, California area, or any other location required by Producer from approximately July 01, 2011 to September 01, 2011. In addition, I understand that I must be available to participate in publicity activities in late November/early December if requested, and to be available to return to the Los Angeles, California area in connection with the December

2011 live Program finale, if requested, as well as on such other days as Producer may require, including attending and participating in all testing sessions, preliminary interviews, rehearsals, conferences, interviews, publicity sessions and costume, hair and make-up appointments, until the completion of my participation in the Program as required by Producer. I understand that these dates may change in Producer's sole discretion.

9. If I am selected by Producer to be a participant on the Program, I understand that I will be required to enter into a comprehensive agreement ("Comprehensive Agreement") with Producer which shall include, without limitation, Producer's exclusive option to sign me to an exclusive recording agreement with Epic Records/Sony Music Entertainment, an exclusive personal management agreement and an exclusive music publishing agreement. The Comprehensive Agreement shall also include, without limitation, Producer's option to acquire my exclusive touring rights and exclusive merchandising rights as well as all other terms and conditions relating to my appearance on and participation in the Program.

10. I understand that Producer may select various applicants to appear in Los Angeles for another phase of the contestant selection process for various purposes, including without limitation, the recording of such applicants' reactions on videotape. I further understand that Producer's inviting me to Los Angeles, California, to the production studio or other "remote," non-studio location for purposes of filming or taping does not constitute or guarantee that I will be selected as a participant on the Program, or that I will appear on the Program. I hereby agree and acknowledge that I cannot rely upon any such statements or actions but rather only upon written notice from Producer's Business Affairs department shall I be officially deemed to be a participant in the Program.

11. I hereby authorize Producer and any person or entity designated by Producer to investigate, access and collect information about me, about any of the statements made by me in my application, this Agreement and Release, any supporting documents and any other documents that I have signed or provided or do sign or provide in connection with my application to be selected as a participant in the Program, or any other written or oral statements I make in connection therewith, to the maximum extent permitted by law. Without limiting the foregoing, I irrevocably authorize Producer and any person or entity designated by Producer to secure information about me and my experiences from my current and former employers, associates, friends, family members, educational institutions, government agencies, any branch of the military, and any references I have provided, and I irrevocably authorize such parties to provide information concerning me. I hereby unconditionally and irrevocably release and forever discharge Producer, the persons or entities designated by Producer, and all such parties and persons from any and all liabilities arising out of or in connection with any such investigation. To the maximum extent permitted by law, I specifically authorize investigation of my employment records, and government records, including, but not limited to, my motor vehicle records, criminal records, military records and consumer reports. I acknowledge and agree that any such information obtained by Producer or by any person or entity designated by Producer, pursuant to this paragraph or otherwise, may be used for purposes of selecting participants in the Program or in the course of producing the Program, or another program, and may be described or otherwise related in and in connection with the Program, or another program, and in connection with any advertising, publicity, promotion or marketing thereof, to the maximum extent permitted by law.

12. I understand that I will be required to perform songs in connection with my audition, and if selected to appear on the Program, as part of my participation in the Program. If chosen to appear on the Program, I understand that Producer will have the right, in Producer's sole discretion, to determine what I sing.

13. I understand that the Program may involve stunts and elements of surprise. I understand and acknowledge that I will not have the right to review or edit any of the Program materials that are to be used. I understand that this Program may be viewed by millions of people throughout the world. I understand that in connection with my appearance on the Program, the disclosure of information to me or by me may be of a personal, sensitive, private, embarrassing, shocking and/or unfavorable nature to me or to others, and I voluntarily agree to assume all risks associated with my participation in the Program, known or unknown, including, but not limited to, risks of bodily injury, non-consensual physical contact, illness, emotional injury, death risks associated with defamation and/or violation of rights of privacy and/or publicity, risks associated with travel and risks of damage to real and personal property, and by my assumption of said risks. I voluntarily agree to bear all of the consequences of such risks. I understand that Producer makes no representations regarding physical/mental health of the Program applicants and/or participants.

14. I understand and agree that the participant selection process will involve subjective decisions made by certain individuals selected by Producer and/or NBCU in their sole discretion. I understand that the participant selection process may also involve subjective decisions made by the public. I further understand that those certain individuals, Producer, NBCU, and/or other persons or entities may be acquainted with or have some familiarity with some or all of the applicants to varying degrees. I further acknowledge and agree that Producer reserves the right to consider and select participants who are not able to attend an open casting call and that Producer shall have sole discretion and control over every aspect of selecting participants and that Producer is under no obligation to me whatsoever in this regard. I understand and agree that all participant selection and elimination decisions shall be final and binding on me in all respects, and shall not be subject to challenge or appeal. Producer is not obligated to use any of the rights granted in this release, including without limitation the right to telecast my appearance, name, voice (singing and speaking) and/or likeness as taped in the Program. If I do appear on the Program or any part thereof, Producer is under no obligation to broadcast or otherwise use or exploit the Program, or any part thereof, or to use, exhibit, telecast or publicize my participation in the Program. I understand and agree that my appearance as a participant on the Program does not constitute a performance, nor entitle me to any wages or salary or similar compensation therefore. I further understand that Producer can change the rules at any time in Producer's sole discretion, including without limitation the participant eligibility rules (including group size limitations, minimum age requirements), the audition rules, the competition rules, the method of participant selection and any other aspect of the applicant, participation and/or Program rules.

15. As lawful consideration for being considered as a participant on the Program, I hereby agree that neither I nor any of my assigns, heirs, guardians and/or legal representatives will institute or support any claims or actions against Producer, Sony

Pictures Television Inc., Sony Pictures Entertainment Inc., Sony Music Entertainment, Inc., NBC Universal Media, LLC, NBC West, LLC, their affiliated entities, indemnitees, successors, agents, managing agents, servants, employees, partners, licensees, attorneys, representatives, principals, officers, directors, shareholders, insurance companies, assignees and/or any other party (the "Released Parties") based upon or arising out of my interview(s), my audition(s), and/or my appearance on, and participation in, the Program and I hereby release, acquit and forever discharge the Released Parties from and against any and all claims, demands and causes of action, demand rights, debts, costs, liens, loss of service, expenses, attorneys' fees, compensation, indemnities and or demands of whatever nature, whether based on contract, tort, statute, regulation or any other legal or equitable theory of recovery which I, my assigns, heirs, guardians, and/or legal representatives may have now or in the future based upon or arising directly or indirectly from my participation in and/or my appearance on the Program, or any exploitation thereof or any exercise by Released Parties of their rights as conveyed in this release on any legal theory whatsoever, including but not limited to (a) any claims for defamation, violation of rights of privacy and/or publicity, intentional infliction of emotional distress, intentional interference with contracts, copyright or trademark infringement, and/or any other tort in connection therewith; (b) claims for personal injury, physical disability, dismemberment, death or damage to real or personal property or any other violation resulting from the gross, active or passive negligence or other acts, howsoever caused, as a result of (i) my participation in the Program, including, without limitation, any travel activities "stunts" and procedures in which I may participate in connection with the Program, (ii) the exploitation of the Program and any advertising or publicity issued in connection with the Program, or (iii) my presence on or about the premises where the Program is produced including, without limitation, any "remote" (i.e. non-studio) premises where the Program and/or segments thereof are taped; (c) the Released Parties' use of my appearance, name, voice, likeness, and singing voice; and (d) any claims associated with the risks enumerated in this Agreement.

16. I hereby agree to defend and indemnify the Release Parties, and each of them, and hold them harmless from any and all liability, claims and actions, including any and all production costs and attorneys' fees, of any nature whatsoever, caused by or arising out of (a) use of my appearance, name, voice (speaking and singing, and likeness, and my statements or actions made in or in connection with my participation on the Program; (b) my following the judges', host's or Producer's advice; (c) any injuries or damages of any kind whatsoever, including, without limitation, personal injury, physical disability, dismemberment, death, real or personal property damage, or any claims for defamation, copyright or trademark infringement, violation of rights of privacy and/or publicity that any person or other entity may sustain as a result of or incident to my participation in the Program; (d) any claims associated with the risks enumerated in this agreement; or (e) breach of this Agreement.

17. Except as specifically provided herein or as otherwise authorized by you, I will not myself, or authorize others to, publicize, advertise or promote my appearance on the Program, receive or generate any monetary advantage from my appearance on the Program, or use or disclose to any party any confidential business information or trade secrets obtained or learned as a result of my participation in the Program. I shall not make any unauthorized mention or "plug" of any commercial product, service, venture or thing

on the air, including the name of my employer. Neither I nor anyone acting on my behalf is giving or receiving any monies, or other valuable consideration to get me on the Program or mention anything on the Program. I am aware that payment or acceptance of, or agreement to pay or accept, any money or valuable consideration for the appearance of any person or the mention of anything on the Program without disclosure to the broadcaster prior to broadcast is a federal offense punishable by fine and/or imprisonment. I agree that if anyone tries to induce me to accept any such payment, I shall immediately notify the Producer. I recognize that a breach by me of this paragraph would cause Producer irrevocable injury and damage that cannot be reasonably or adequately compensated by damages in an action at law and, therefore, I hereby expressly agree that Producer shall be entitled to injunctive and other equitable relief to prevent and/or cure any breach or threatened breach of this paragraph.

18. Any controversy of claim arising out of or relating to this Agreement, its enforcement, arbitrability or interpretation shall be submitted to final and binding arbitration, to be held in Los Angeles, County, California, before a single arbitrator, in accordance with California Code of Civil Procedure §1280 et seq. The arbitrator shall be selected by mutual agreement of the parties or, if the parties cannot agree, then by striking from a list of arbitrators supplied by JAMS. The arbitration shall issue a written opinion stating the essential findings and conclusions upon which the arbitrator's award is based. The arbitrator has the power to issue injunctive relief which may be enforced by a court. The parties will share equally in payment of the arbitrator's fees and arbitration expenses and any other costs unique to the arbitration hearing (hereinafter "Arbitration Costs"). If, however, the principles of Armendariz v. Foundation Health Psychare Services, 24 Cal.4th 83 (2000), require Sony Pictures to pay the full Arbitration Costs, then Sony Pictures shall do so. The parties recognize that each side bears its own deposition, witness, expert and attorneys' fees and other expenses to the same extent as if the matter were being heard in court.

19. I understand and agree that all rights under Section 1542 of the Civil Code of California and similar law of any state or territory of the United States are hereby expressly waived. Said section reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

20. I have been given ample opportunity to read, and I have carefully read this entire Agreement. I represent and warrant that I have the full right, power and authority to grant the rights herein. I understand that Producer is making substantial expenditures in reliance upon my consent and that I may not revoke the rights I have granted here. I am aware that this is a release of liability for future injuries and a contract between myself and Producer and/or its affiliated entities, and sign it of my own free will. I hereby certify that I intend to be legally bound hereby. I agree that no promises have been made to me other than as set forth in this release, and I have not relied upon any representations or other

statements not contained in this agreement. I acknowledge that I have been offered a copy of this Agreement.

I UNDERSTAND THAT I AM GIVING UP CERTAIN LEGAL RIGHTS UNDER THIS AGREEMENT, INCLUDING WITHOUT LIMITATION, MY RIGHT TO FILE A LAWSUIT IN COURT WITH RESPECT TO ANY CLAIM ARISING IN CONNECTION WITH THIS AGREEMENT.

The undersigned shall do any and all things reasonably necessary and reasonably required by Producer to assist in the full and complete performance by the Minor of the Minor's representations, warranties, undertakings, indemnifications, releases, disclosures, acknowledgements, assignments, grants, engagements, approvals, conveyances, covenants, obligations, and Applicant Agreements (collectively "obligations") under the Applicant Agreement, including, without limitation, acting as guardian to the Minor in connection with all of the Minor's undertakings and obligations under the Applicant Agreement, provided that if Producer wants to have the Applicant Agreement court-approved, Producer shall reimburse Minor or the undersigned for all actual, out-of-pocket costs incurred in connection with obtaining such court approval.
4. The undersigned hereby guarantees to Producer the full and complete performance by the Minor of each and all of the Minor's obligations as set forth in the Applicant Agreement.
5. If there is only one parent/guardian, the undersigned represents and warrants that they have the sole ability to grant the right for the Minor to participate in the Program to the full extent set forth in the Applicant Agreement and that no other party (other than the Minor once the Minor is 18) has a right to claim otherwise or to disaffirm the Applicant Agreement between Producer and the Minor.
6. The consideration provided in the Applicant Agreement whether implicit or explicit shall be deemed to be the consideration in full for all rights in the Applicant Agreement and herein granted and agreed to be granted to Producer and for all obligations, pursuant to the Applicant Agreement and pursuant to this Parental Consent, not only by the Minor but also by the undersigned.
7. The undersigned agrees to execute any documents or papers, to cooperate in any proceeding, and to comply with any applicable laws, regulations and/or requirements concerning contracts with minors.
8. The undersigned hereby expressly agrees to and shall indemnify Producer and the Released Parties as defined in the Applicant Agreement ("Released Parties") from any and all costs incurred and any and all loss of any nature or kind whatsoever arising from or relating to any claims made by or on behalf of the Minor relating to the subject matter of the Applicant Agreement and/or this Parental Consent, other than as may be expressly provided for in the Applicant Agreement.
9. The undersigned hereby expressly agrees to and shall indemnify Producer and the Released Parties from any and all costs incurred and any and all loss of any nature or kind whatsoever arising from or relating to the breach of any guarantee(s) made by the undersigned in this Parental Consent.
10. The undersigned expressly agrees that the provisions of this Parental Consent shall apply and relate with full force and effect not only to the Applicant Agreement including any and all exhibit(s) thereto, but as well to any and all written supplements, modifications and amendments thereto that may be signed by the undersigned.

If the names of two or more persons appear as the undersigned in the opening paragraph of this Parental Consent or if this Parental Consent is executed by two or more persons, then this Parental Consent shall be binding jointly and severally upon said persons and each of them, and each and all of the obligations on the part of the undersigned hereinabove set forth

shall be and be deemed to be joint and several. Any reference to any singular number herein shall be deemed to include the plural numbers, if the context so requires.
